AN ORDINANCE AMENDING ORDINANCE NO. 7647. **ADOPTED APRIL 4, 2019, ENTITLED,** "AN ORDINANCE AMENDING TITLE XI. CHAPTER 110. SECTION 110.11: **TITLE XI, CHAPTER 112; AND TITLE XI, CHAPTER 115** OF THE LOMBARD VILLAGE CODE IN REGARD TO VIDEO GAMING AND LIQUOR LICENSES FOR ESTABLISHMENTS WITH VIDEO GAMING"

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Section 14 of Ordinance No. 7647, adopted April 4, 2019, is hereby amended by revising the reference therein to "June 30, 2020" to read "December 31, 2020,"

SECTION 2: That Section 15 of Ordinance No. 7647, adopted April 4, 2019, is hereby amended as follows:

- The references therein to "June 30, 2020" are hereby revised to read Α. "December 31, 2020"; and
- The references therein to "July 1, 2020 to December 31, 2020" are hereby B. revised to read "January 1, 2021 through June 30, 2021".

SECTION 3: That Section 16 of Ordinance No. 7647, adopted April 4, 2019, is hereby amended by revising the reference therein to "June 30, 2020" to read "December 31, 2020".

SECTION 4: That all other provisions of Ordinance No. 7647, adopted April 4, 2019, not amended hereby, shall remain in full force and effect.

SECTION 5: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
