SUBJECT: Designation of Maple Street between Main Street and Elizabeth Street as

the Honorary Ellen Martin Way

On April 6, 1891, Ellen Martin led fourteen (14) women to the local polling place to vote in the municipal election in Lombard, IL. After much debate, the women were allowed to cast their vote. This marked the first time in the State of Illinois that women were given the right to vote. Ms. Martin's vote on April 6, 1891 took place twenty-nine (29) years before the ratification of the 19th amendment allowing women the right to vote in all elections.

The Lombard Historical Society, has been working with the National Votes for Women Trail (NVWT), a committee of the National Collaborative for Women's History Sites (NCWHS) to award Lombard a grant to place one of five state markers to commemorate important moments in women's suffrage history to be placed in Lombard. This marker would forever be a reminder of the contribution that Lombardian Ellen Martin had to the Women's Suffrage Movement. A historical marker will be placed at the Victorian Cottage located at 23 W. Maple to commemorate Ms. Martin's casting of the first vote in Illinois by a woman.

In addition to the historical marker denoting the approximately location where Ms. Martin cast that first ballot, the Lombard Historical Society has requested that the Village Board designate the roadway adjacent to the location as "Honorary Ellen Martin Way". Per Section 152.28 (A) of the Village Code, the Village Board may authorize the designation of a public roadway as an honorary street. The Lombard Historical Society, supported by several other agencies /entities has requested that the Village Board designate Maple Street between Main Street and Elizabeth as "Honorary Ellen Martin Way" to honor the legacy of Ellen Anette Martin.

Staff has reviewed the request and determined that the request complies with the Village Code relative to the honorary designation of a public roadway. As such, I respectfully request that this matter be placed on the Village Board agenda for the March 19, 2020 meeting for consideration.

Recommendation

Staff recommends that the Village President and Board of Trustees authorize the designation of Maple Street between Main Street and Elizabeth Street as "Honorary Ellen Martin Way".

Dear President Giagnorio

On April 6, 1891, Ellen Martin led fourteen women to the local polling place to vote in the municipal election in Lombard, IL. After much debate, the women were allowed to cast their vote and their voices counted. This marked the first time in the State of Illinois women were given the right to vote. It then took a full 29 years before women's suffrage was made legal nationwide, four years after Martin's death.

August 26, 2020 marks the 100th anniversary of the ratification of the 19th amendment allowing women the right to vote in all elections. There are many commemorations taking place both locally and nationally. The Lombard Historical Society with Tim Frakes Productions, Inc is creating a documentary to mark this event. LHS is also hosting programs and exhibits highlighting women's suffrage. We are also working on national plaque recognition for this Illinois event.

With that, we are respectfully asking that the Village of Lombard Board of Trustees pass an ordinance to name West Maple Street between Main Street and Elizabeth Street "Honorary Ellen Martin Way." This location is central to where Ellen Martin as well as many of the other original female voters lived. The Lombard Historical Society is also asking the Village waive any fees associated with said naming.

We look forward to working with the community development department, fire, police and public works on this project. Our hope is that the street signs could be unveiled on April 6 to honor the original voting date of the Ladies of Lombard.
