EXECUTIVE ORDER NO. 2020-04

EXECUTIVE ORDER REGARDING PACKAGE GOODS SALES OF LIQUOR UNDER A DECLARATION OF A STATE OF EMERGENCY IN THE VILLAGE OF LOMBARD, DUPAGE COUNTY, ILLINOIS

(COVID-19 - MARCH 20, 2020)

- WHEREAS, the Village of Lombard (the "Village") is a non-home rule unit of local government, as provided by Article VII, Section 7 of the Illinois Constitution of 1970; and
- WHEREAS, COVID-19 is a dangerous disease which has spread around the world, including in the United States, the State of Illinois and DuPage County; and
- WHEREAS, COVID-19 is a direct and serious threat to the public's health, safety and welfare; and
- WHEREAS, on March 20, 2020, the Village President declared a state of emergency in the Village in Declaration 2020-1, entitled "Declaration of a State of Emergency in the Village of Lombard, DuPage County, Illinois (COVID-19 March 20, 2020)" (the "Declaration"); and
- **WHEREAS**, the Declaration was made pursuant to authority granted to the Village President in Section 31.18 of the Lombard Village Code, entitled "Village President's Authority to Declare a State of Emergency," and pursuant to Section 11-1-6 of the Illinois Municipal Code (65 ILCS 5/11-1-6); and
- **WHEREAS**, the Village President has determined that it is necessary to make this Executive Order to best protect the public's health, safety and welfare regarding COVID-19:
- **NOW, THEREFORE, BE IT ORDERED,** by the Village President of the Village of Lombard, DuPage County, Illinois, as follows:
- **SECTION 1**: **Incorporation.** That the recitals above shall be and are incorporated in this Section 1 as if restated herein.

SECTION 2: Executive Order. That it is ordered as follows:

1. Local liquor license holders, that are prevented from providing on-premises consumption of food or alcoholic beverages as a result of State of Illinois Executive Order 2020-7, may temporarily conduct packaged goods sales of alcoholic beverages "inperson," on a "to-go" basis, and by delivery for off-premises consumption, for so long as the on-premises consumption of food or alcoholic beverages is prevented, whether by State of Illinois Executive Order 2020-7 or by a newly issued State of Illinois Executive

Order. The alcoholic beverages which may be sold for off-premises consumption under this Executive Order shall be limited to only those types of alcoholic beverages which are authorized by the current local liquor license class of the liquor licensee for on-premise consumption. All alcoholic beverages sold pursuant to this Executive Order shall be packaged goods corked, capped, sealed and labeled by the manufacturer of alcoholic liquor, sold in said corked, capped, sealed and labeled condition, for consumption at a location other than the premises where sold, consistent with the definition of packaged goods as set forth in Section 112.02 of the Lombard Village Code. The authority granted by this Executive Order shall immediately cease upon termination of this Executive Order or the resumption of the ability of the liquor licensee to sell food and alcoholic beverages on the licensed premises, whichever comes first.

SECTION 3: Duration. That this Executive Order shall expire upon the earlier of: (a) the Declaration ending; or (b) withdrawal of this Executive Order by the Village President.
