Trustee Dan Whittington noted that he will be abstaining from voting on this matter. He stated that his wife has been the General Manager of the Vino Cellar to assist the owners. He stated that he works there, but does not receive a salary. Approximately six months ago, the owners indicated they wanted to sell the business. He and his wife would prefer to be allowed to purchase the business instead of the business closing. This matter has been carefully reviewed by legal counsel.

Village Manager Scott Niehaus stated originally the State of Illinois prohibited any elected officials from holding a liquor license. The State has since changed the Code and the Village has mirrored the State Code relative to liquor licensing. The amendment to Village Code would allow an elected official to have a liquor license. Village Attorney Tom Bayer stated that the Village is amending its Code to be in compliance with the State Code. Any elected official holding a liquor license is not allowed to vote on any liquor license matters or participate in any discussions relative to liquor licenses. President Giagnorio stated this is more of a clerical matter to reflect the State Code. He also felt that the current Code restricted the pool of candidates who might consider running for office in the Village. Trustee Bill Ware concurred with the recommendation and did not feel an elected official should be discriminated against relative to liquor

licensing. He felt all elected officials should be allowed to have a liquor license.
