Lombard Historical Society President, Leslie Sulla, provided copies of the following report as summarized:

Highlights:

2018 Cash Raffle - all proceeds to pay off the loan for the Peck Foundation repairs. Drawing will be Sunday, July 29. Civil War Encampment July 28 & 29 at Four Seasons Park. The Peck Garden is now accessible! The Lombard Park District extended a ramp into the garden and built raised garden beds. Visitors can enjoy the colors, scents, and feel of our sensory garden. Cucumbers have begun being harvested.

A new exhibit coming to Carriage House August - September: "Vinyl Warning" - a record collection.

Public Works will be adding a sidewalk to Plum's potting shed (formerly chicken coop) and have given preliminary approval for HVAC. The plan is to turn the structure into a gift shop.

Program Coordinator Colette Freeman attended a June conference "Reinventing the Historic House Museum." Topics ranged from fundraising to membership to volunteers. She's working on how to implement some of the suggestions.
