He stated that there are many rules regarding the use of the drones by law enforcement. Illinois has a strict drone use law; the drone cannot be used to conduct surveillance. A local application of the drone might include missing persons, natural disasters, crime scene photography, crash investigations, and promotion of events or the community.*
